1 Who are Seadream Education CIC?

Seadream Education CIC is a non-profit Community Interest Company set up by marine biologist Dr Juliette Jackson to deliver exciting science and engineering to instil passion, awe, knowledge, understanding and respect for the world around us.

- Seadream Education CIC delivers interactive science and engineering workshops.
- Performs tailored outreach to schools and clubs throughout the South West of England.
- Delivers public engagement activities.
- Carries out small research projects in collaboration with organisations such as Plymouth University and the Environment Agency.
- Seeks funding and collaborative opportunities for education and research
- Delivers the “Ocean Discovery Zone” at festivals and large events

2 Registration with the ICO as a Data Controller

As a small, not-for-profit organisation, Seadream CIC is exempt from the need to register with the ICO as a Data Controller/Processor.

3 Data Inventory

A summary of our inventory is accessible upon request. This is reviewed on a six month basis.

4 Legal Basis for collecting and Processing Data

There are three main purposes requiring Seadream CIC to process a minimum amount of personal data. All data collected are listed and described in the Data Inventory.

4.1 Contract

Where Seadream CIC enters into a contract to provide services such as outreach, workshops, resources or research, Seadream will collect and manage the necessary personal data to fulfil that contract e.g. contact details for grant providers.

4.2 Consent

Seadream will collect consent data for participation in surveys to improve our service and the use of photographs in educational or dissemination purposes.

4.3 Legitimate Interest Assessment

Seadream may record personal data for research into areas such as impact assessment and contribution to best practice guidance in education and outreach.

5.1 External posts to our social media pages

Posts to any of our social media sites will be reviewed and are subject to the privacy policy of the social media provider. Where contributions are made to our research using a social media platform e.g. posting photos of jellyfish on the South Devon Jellyfish Survey Facebook page, the information provided will be saved and recorded electronically. This will include the date of the post, the information provided (e.g.

about the jellyfish sighting) and the source (e.g. Facebook post, Instagram comment). Personal information will not be extracted. Only necessary information to allow validation of the research findings will be kept. Research data will be destroyed 5 years after the end of the study.

All personal information is treated as confidential.
